13-81 Motion made by Mr. Rubin to pass the following resolution required by Ohio Police and Fire Pension Fund:

WHEREAS, the eligible employees of Liberty Township Fire Department participate in the Ohio Police and Fire Pension Fund (OP &F);

WHEREAS, the Board of Liberty Township Trustees desires to pickup all of the mandatory contributions required to be paid under Section 742.31 of the Ohio Revised Code for participating employees of the Liberty Township Fire Department who are members of the OP & Fund;

WHEREAS, OP & F has adopted new procedures for reporting picked up contributions in order to properly prepare 1099-R forms for its members;

WHEREAS, the Liberty Township Board of Trustees wishes reaffirm, amend and/or restate its prior resolution in order to continue the pick-up under the new procedures;

NOW THEREFORE, BE IT RESOLVED, that effective as of July 7, 2013, July 6, 2014 and July 5, 2015, the Board has determined to continue to pick-up all the mandatory contributions by the employees who are members of the Ohio Police and Fire Pension Fund by paying the contributions through a payroll reduction as follows: by paying up to but not exceeding a total of twelve percent (12%) or to a rate as established by the Ohio Police and Fire Pension Fund except those hired on or after January 1, 2011, the employee will be responsible for and shall pay the statutory employee pension contribution. The employer shall not pay any pension pick up for those hired after January 1, 2011.

BE IT FURTHER RESOLVED, that said picked up contributions paid through a payroll reduction, even though designated as employee contributions for state law purposes, are being paid by the Board Of Liberty Township in lieu of said contributions by the eligible employees;

BE IT FURTHER RESOLVED, that said picked up contributions will not be included in the gross income of the employees for tax reporting purposes, that is, for federal or state income tax withholding taxes, until distributed from the Ohio Police and Fire Pension Fund;

BE IT FURTHER RESOLVED, that said picked up contributions will be included in the gross income of the employees, for employment tax purposes, as the contributions are made to the Ohio Police and Fire Pension Fund; and

BE IT FURTHER RESOLVED that said employees shall not be entitled to any option of choosing to receive the contributed amounts directly instead of having them paid by the Board of Liberty Township to the Ohio Police and Fire Pension Fund.

Liberty Township agrees to participate in a feasibility study to use Local Government Innovation Fund (LGIF) dollars to analyze and chart the feasibility and potential of converting local government and school district fleets to a National Gas Vehicle (NGV) fleet. The study will also map out a "Shared Service" distribution network, reducing storage, transportation, and purchasing costs. It is agreed that the NCOESC shall bear the costs associated with the LGIF grant application, take responsibility for administering the grant award, and will coordinate date collection during the study.
