NOW THEREFORE BE IT RESOLVED that the following regulations for the commercial timbering of property in the unincorporated area of the Liberty Township be and hereby are adopted, pursuant to the authority of the limited self-government of townships (Chapter 504 Ohio Revised Code) and approved upon First and Second readings and Publication and Codification.

SECTION 1: Timbering Permit

A. No person or entity shall engage in commercial timbering of any real property located in the unincorporated area of Liberty Township without first obtaining a permit from the Code Enforcement Officer.

Any person or entity shall, before commencing commercial timbering activity shall make application for and obtain a timbering permit.

The Application for permit shall contain the following information:

- 1. The name, address and telephone number of the person or entity that will be conducting the actual cutting and removal of trees on the property. If said person or entity is a corporation, they shall provide a copy of the certificate of incorporation and proof that the corporation is in good standing with the Ohio Secretary of State; if the person or entity is a partnership, the name and address of at least one general partner and copies of any partnership documentation filed with the Ohio Secretary of State
- 2. The name of the owner of record; street address and Trumbull County Auditor's Permanent Real Estate Parcel ID Number of the property to be timbered.
- 3. The date of commencement of timbering activities and the estimated completion date.

SECTION 2: TIMBERING OPERATION RULES

- A. Permit holders shall daily, remove and clean up any mud and/or debris left on the township roads as a result of the timbering activities, including but not limited to vehicles and equipment traveling on State, County and Township roads and debris on the roads from the timbered property.
- B. Timbering activities shall be conducted during the following days and times:
 - a) Monday through Friday 8:00 AM to 8:00PM

- b) Saturday 8:00 AM to 6:00 PM
- c) All timbering is prohibited on Sundays

SECTION 3: COMPLETION OF OPERATIONS; RESTORATION OF PROPERTY

- A. The permit holder shall complete timbering activities on or before the date of completion as represented and stated in the permit, unless for good cause an extension is applied for and approved by the code enforcement officer.
- B. Upon completion of the commercial timbering activities, the permit holder shall remove all cut and downed timber and debris and shall repair all ruts and damage to the property to restore the property to its pre-commercial timbering condition less the timber removed. The permit holder shall contact the code enforcement officer and arrange a meeting with the code enforcement officer on the premise to inspect the property and issue a certificate of compliance of clean up and restoration to the permit holder.

SECTION 4: PENALTIES

Whoever violates this resolution is subject to the following civil fines: A violation of Section 1:

a) First Offense \$ 500.00

b) Second and Subsequent Offenses \$1,000.00

A violation of Sections 2 and 3 per permit;

a)	First Offense	\$ 250.00
b)	Second Offense	\$ 500.00
c)	Third Offense	\$ 750.00
d)	Fourth and subsequent offenses	\$1,000.00

Each day of non-compliance at the permit location shall constitute a separate offense.

SECTION 1 – Project Description

WHEREAS, the STATE has identified the need for the described project:

Bridge improvements to Shady Rd bridge over IR 80 in Liberty Township, including the Installation of lighting.

NOW THEREFORE, be it ordained by Liberty Township, LPA of Trumbull County, Ohio.

SECTION II - Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III – Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

The LPA agrees to participate in the cost of construction for transportation enhancement fund eligible lighting expenses at a minimum of twenty percent (20%) total cost. Any costs above the funds manger's stated federal maximums will be the responsibility of the LPA. This includes the construction contract and construction engineering.

The LPA further agrees to pay One Hundred Percent (100%) of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to be unnecessary for the Project.

SECTION IV – Utilities and Right-of-Way Statement

The LPA agrees to acquire and/or make available to ODOT, in accordance with current State and Federal regulations, all necessary right-of-way costs, include eligible utility costs. The LPA agrees to be responsible for all utility accommodation, relocation, and reimbursement and agrees that all such accommodations, relocations, and reimbursements shall comply with the current provisions of 23 CFR 645 and the ODOT Utilities Manual.

SECTION V – Maintenance

Upon completion of the described Project, and unless otherwise agreed, the LPA shall: (1) provide adequate maintenance for the described Project in accordance with all applicable state and federal law, including, but not limited to, 23 USC 116; (2) provide ample financial provisions, as necessary, for the maintenance of the described Project; (3) maintain the right-of-way, keeping it free of obstructions; and (4) hold said right-of-way inviolate for public highway purposes.

SECTION VI - Consultants and Authority to Sign

The Administrator of said Liberty Township, LPA is hereby empowered on behalf of the Liberty Township, LPA to enter into contracts with ODOT pre-qualified consultants for the preliminary engineering phase of the Project and to enter into contracts with the Director of Transportation necessary to complete the above described project.

Upon the request of ODOT, the Administrator is also empowered to assign all rights, title, and interests of Liberty Township, LPA to ODOT arising from any agreement with its consultant in order to allow ODOT to direct additional or corrective work, recover damages due to errors or omissions, and to exercise all other contractual rights and remedies afforded by law and equity.

The LPA agrees that if Federal Funds are used to pay the cost of any consultant contract, the LPA shall comply with 23 CFR 172 in the selection of its consultant and the administration of the consultant contract. Further the LPA agrees to incorporate OTOT's "Specifications for Consulting Services" as a contract document in all of its consultant contract. The LPA agrees to require, as a scope of services clause, that all pans prepared by the consultant must co form to ODOT's current design standards and that the consultant shall be responsible for ongoing consultant involvement during the construction pause of the Project. The LPA agrees to include a completion schedule acceptable to ODOT and to assist ODOT in rating the consultant's performance through ODOT's Consultant Evaluation System.

SECTION II – Consent Statement

Being in the public interest, the LPA gives consent to the Director of Transportation to complete the above described project.

SECTION III - Cooperation Statement

The LPA shall cooperate with the Director of Transportation in the above described project as follows:

The LPA agrees to participate in the cost of construction for transportation enhancement fund eligible lighting expenses at a minimum of twenty percent (20%) total cost. Any costs above the funds manger's stated federal maximums will be the responsibility of the LPA. This includes the construction contract and construction engineering.

The LPA further agrees to pay One Hundred Percent (100%) of the cost of those features requested by the LPA which are determined by the State and Federal Highway Administration to be unnecessary for the Project.

SECTION 1: Timbering Permit

A. No person or entity shall engage in commercial timbering of any real property located in the unincorporated area of Liberty Township without first obtaining a permit from the Code Enforcement Officer. Any person or entity shall, before commencing commercial timbering activity shall make application for and obtain a timbering permit.

The Application for permit shall contain the following information:

- 1. The name, address and telephone number of the person or entity that will be conducting the actual cutting and removal of trees on the property. If said person or entity is a corporation, they shall provide a copy of the certificate of incorporation and proof that the corporation is in good standing with the Ohio Secretary of State; if the person or entity is a partnership, the name and address of at least one general partner and copies of any partnership documentation filed with the Ohio Secretary of State
- 2. The name of the owner of record; street address and Trumbull County Auditor's Permanent Real Estate Parcel ID Number of the property to be timbered.
- 3. The date of commencement of timbering activities and the estimated completion date.

SECTION 2: TIMBERING OPERATION RULES

- A. Permit holders shall daily, remove and clean up any mud and/or debris left on the township roads as a result of the timbering activities, including but not limited to vehicles and equipment traveling on State, County and Township roads and debris on the roads from the timbered property.
- B. Timbering activities shall be conducted during the following days and times:
 - a) Monday through Friday 8:00 AM to 8:00PM
 - b) Saturday 8:00 AM to 6:00 PM
 - c) All timbering is prohibited on Sundays

SECTION 3: COMPLETION OF OPERATIONS; RESTORATION OF PROPERTY

- A. The permit holder shall complete timbering activities on or before the date of completion as represented and stated in the permit, unless for good cause an extension is applied for and approved by the code enforcement officer.
- B. Upon completion of the commercial timbering activities, the permit holder shall remove all cut and downed timber and debris and shall repair all ruts and damage to the property to restore the property to its pre-commercial timbering condition less the timber removed. The permit holder shall contact the code enforcement officer and arrange a meeting with the code enforcement officer on the premise to inspect the property and issue a certificate of compliance of clean up and restoration to the

permit holder.

WHEREAS, The Board of Trustees of Liberty Township passed, by unanimous vote, a resolution on May 14, 2007, to place the issue of adopting a limited home rule government on the ballot pursuant to Ohio Revised Code Section 504.01(A);

WHEREAS, the electors of Liberty Township voted on November 6, 2007 to establish a limited home rule government pursuant to Ohio Revised Code Section 504.01(A);

WHEREAS, it is the desire of the Liberty Township Board of Trustees to adopt a Home Rule Resolution to address the need to abate public nuisances, as herein defined, and promote property owner and/or landlord responsibility for activities occurring upon their property and/or property within their control:

NOW THEREFORE BE IT RESOLVED THAT THE FOLLOWING REGULATIONS BE AND HEREBY ARE ADOPTED AND APPROVED UPON FIRST AND SECOND READINGS, PUBLICATION AND CODIFICATION:

SECTION 1: PUBLIC NUISANCES DEFINED

The following activities, occurring on property within the unincorporated area of the township and engaged in by an owner, lessee, occupant or invitee of the owner or occupant, are hereby declared to be public nuisances:

- 1. Any disorderly conduct, disturbance of the peace, noise or other similar violation under Township Resolutions and/or statutes of the State of Ohio;
- 2. Any drug abuse violation under Township Resolutions and/or statutes of the State of Ohio;

- 3. Any gambling violation under Township Resolutions and/or statutes of the State of Ohio;
- 4. Any health, safety, or sanitation violations under Township Resolutions and/or statutes of the State of Ohio;
- 5. Any obstruction of official business violations under Township Resolutions and/or statutes of the State of Ohio:
- 6. Any alcohol violation under Township Resolutions and/or statutes of the State of Ohio;
- 7. Any sex offense under Township Resolutions and/or statutes of the State of Ohio, including but not limited to public indecency, solicitation, and prostitution;
- 8. Any offense against another person under Township Resolutions and/or statutes of the State of Ohio, including but not limited to assault, battery, menacing, endangering children, and contributing to the unruliness and/or delinquency of a child.
- 9. Any offense against property under Township Resolutions and/or statutes of the State of Ohio, including but not limited to criminal damaging, criminal mischief, burglary and arson.
- 10. Any theft violation under Township Resolutions and/or statutes of the State of Ohio, including but not limited to theft and receiving stolen property.
- 11. Any fireworks violation under Township Resolutions and/or statutes of the State of Ohio;
- 12. Any open burning or recreational fires in violation of Township Resolutions and/or statutes of the State of Ohio;
- 13. Any activity engaged in by a person under eighteen years of age which would constitute a violation of an offense listed in this section if committed by an adult.

SECTION 2: NOTICES AND ORDERS

The Chief of Police of the Township or his designee, upon finding that three or more nuisance activities declared in Section 1 have occurred on township property within any twelve (12) month period, shall cause a written notice and order to be served on the owner and/or landlord of the property, declaring that such property is a nuisance property. The notice and order shall set forth:

- 1. The nature of the nuisances;
- 2. The dates and times that the police have previously been called to the property;
- 3. That subsequent responses by the police to the property in question for the same nuisance will result in fines to the property owner/landlord;
- 4. The amount of fines to be assessed in the event of subsequent responses; and
- 5. That the property owner/landlord may avoid being charged costs of responses by taking steps to prevent any further nuisance activities as defined in this Resolution.

Notice and order shall be served on the property owner and/or landlord personally or by certified mail and regular mail to the person's residence, regular place of business or last known address. If the certified or regular mail is returned undelivered, a copy shall be posted in a conspicuous place in or on the person's residence, regular place of business, last known address or on the property affected.

If, within twelve (12) months, the police response to a fourth or successive nuisance activities on the property, the property owner and/or landlord will be charged with a violation of this resolution and upon conviction, will be assessed the civil fines as prescribed in Section 3 of this Resolution. The Chief of Police or designee shall issue a home rule citation to the property owner or landlord of the property.

SECTION 3: AFFIRMATIVE DEFENSES

It shall be an affirmative defense of the property owner and or landlord, and a bar to imposition of the fines set forth in Section 4, if the property owner and or landlord demonstrates that:

- 1. He/She was not the owner of the property at the time of the occurrence of the prior activities; or
- 2. He/She, having received notice of the nuisance activity, promptly took reasonable and necessary action to abate each nuisance; or
- 3. He/She having received notice of the nuisance activity, evicted, ejected or removed from occupancy or possession of the property those persons causing the nuisance; or

- 4. He/She having received notice of the nuisance activity, took action to reasonably secure the property from unwanted entry or trespass of the property; or
- 5. He/She is prohibited by law to take any action to abate the nuisance; or
- 6. The nuisance is entirely outside of the control or authority of the property owner or landlord to take reasonable action to abate the nuisance.

SECTION 4: PENALTIES

A violation of this Resolution, whereby the police are responding to a fourth or more nuisance at the property, shall constitute an unclassified civil misdemeanor punishable by a civil fine as follows:

(1)	First Offense	\$250.00+
(2)	Second Offense	\$500.00
(3)	Third Offense	\$750.00
(4)	Fourth and Subsequent Offenses	\$1,000.00

SECTION 5: EFFECTIVE DATE OF RESOLUTION

This Resolution shall be effective thirty (30) days from the date of adoption upon both First and Second Readings, and publication thereof.

WHEREAS, the electors of Liberty Township voted on November 6, 2007 to establish a limited home rule government pursuant to Ohio Revised Code Section 504.01(A);

WHEREAS, it is the desire of the Liberty Township Board of Trustees to adopt a Home Rule

Resolution to address the need to abate public nuisances, as herein defined, and promote property owner and/or landlord responsibility for activities occurring upon their property and/or property within their control:

NOW THEREFORE BE IT RESOLVED THAT THE FOLLOWING REGULATIONS BE AND HEREBY ARE ADOPTED AND APPROVED UPON FIRST AND SECOND READINGS, PUBLICATION AND CODIFICATION:

SECTION 1: PUBLIC NUISANCES DEFINED

The following activities, occurring on property within the unincorporated area of the township and engaged in by an owner, lessee, occupant or invitee of the owner or occupant, are hereby declared to be public nuisances:

- 1. Any disorderly conduct, disturbance of the peace, noise or other similar violation under Township Resolutions and/or statutes of the State of Ohio;
- 2. Any drug abuse violation under Township Resolutions and/or statutes of the State of Ohio;
- 3. Any gambling violation under Township Resolutions and/or statutes of the State of Ohio;
- 4. Any health, safety, or sanitation violations under Township Resolutions and/or statutes of the State of Ohio;
- 5. Any obstruction of official business violations under Township Resolutions and/or statutes of the State of Ohio;
- 6. Any alcohol violation under Township Resolutions and/or statutes of the State of Ohio;
- 7. Any sex offense under Township Resolutions and/or statutes of the State of Ohio, including but not limited to public indecency, solicitation, and prostitution;

- 8. Any offense against another person under Township Resolutions and/or statutes of the State of Ohio, including but not limited to assault, battery, menacing, endangering children, and contributing to the unruliness and/or delinquency of a child.
- 9. Any offense against property under Township Resolutions and/or statutes of the State of Ohio, including but not limited to criminal damaging, criminal mischief, burglary and arson.
- 10. Any theft violation under Township Resolutions and/or statutes of the State of Ohio, including but not limited to theft and receiving stolen property.
- 11. Any fireworks violation under Township Resolutions and/or statutes of the State of Ohio;
- 12. Any open burning or recreational fires in violation of Township Resolutions and/or statutes of the State of Ohio;
- 13. Any activity engaged in by a person under eighteen years of age which would constitute a violation of an offense listed in this section if committed by an adult.

SECTION 2: NOTICES AND ORDERS

The Chief of Police of the Township or his designee, upon finding that three or more nuisance activities declared in Section 1 have occurred on township property within any twelve (12) month period, shall cause a written notice and order to be served on the owner and/or landlord of the property, declaring that such property is a nuisance property. The notice and order shall set forth:

- 1. The nature of the nuisances;
- 2. The dates and times that the police have previously been called to the property;
- 3. That subsequent responses by the police to the property in question for the same nuisance will result in fines to the property owner/landlord;
- 4. The amount of fines to be assessed in the event of subsequent responses; and
- 5. That the property owner/landlord may avoid being charged costs of responses by taking steps to prevent any further nuisance activities as defined in this Resolution.

Notice and order shall be served on the property owner and/or landlord personally or by certified mail and regular mail to the person's residence, regular place of business or last known address. If the certified or regular mail is returned undelivered, a copy shall be posted in a conspicuous place in or on the person's residence, regular place of business, last known address or on the property affected.

If, within twelve (12) months, the police response to a fourth or successive nuisance activities on the property, the property owner and/or landlord will be charged with a violation of this resolution and upon conviction, will be assessed the civil fines as prescribed in Section 3 of this Resolution. The Chief of Police or designee shall issue a home rule citation to the property owner or landlord of the property.

SECTION 3: AFFIRMATIVE DEFENSES

It shall be an affirmative defense of the property owner and or landlord, and a bar to imposition of the fines set forth in Section 4, if the property owner and or landlord demonstrates that:

- 1. He/She was not the owner of the property at the time of the occurrence of the prior nuisance activities; or
- 2. He/She, having received notice of the nuisance activity, promptly took reasonable and necessary action to abate each nuisance; or
- 3.. He/She having received notice of the nuisance activity, evicted, ejected or removed from occupancy or possession of the property those persons causing the nuisance; or
- 4. He/She having received notice of the nuisance activity, took action to reasonably secure the property from unwanted entry or trespass of the property; or
- 5. He/She is prohibited by law to take any action to abate the nuisance; or
- 6. The nuisance is entirely outside of the control or authority of the property owner or landlord to take reasonable action to abate the nuisance.

SECTION 4: PENALTIES

A violation of this Resolution, whereby the police are responding to a fourth or more nuisance at the property, shall constitute an unclassified civil misdemeanor punishable by a civil fine as follows:

(1)	First Offense	\$250.00+
(2)	Second Offense	\$500.00
(3)	Third Offense	\$750.00
(4)	Fourth and Subsequent Offenses	\$1,000.00
