It is understood and agreed by this applicant that any error, misstatement or misrepresentations of material fact, either with or without intention on the part of the applicant, such as might or would cause a refusal of this application, or any material alteration or change in the accompanying plans made subsequent to the issuance of a Permit in accordance with this application, without the approval of the Township of Liberty, shall constitute sufficient grounds for the revocation of such permits.

**NOTE:** No building or structure shall be built or placed on easements. The applicant shall be responsible for locating easements on the property. If a building or structure should be placed on an easement the owner of the property shall be liable for its removal.

*Any piping of open ditches must comply with the Township, State and County requirements. Driveway Pipe must be approved by the Liberty Township Road Department. There is to be no blockage to existing water course or natural drainage*
