WHEREAS, Section 505.10 of the Ohio Revised Code permits a board of township trustees to sell personal property, including motor vehicles, road machinery, equipment, tools, or supplies, which is not needed for public use, or is obsolete, or is unfit for the use for which it was acquired; and

WHEREAS, the Board of Township Trustees of Liberty Township, Trumbull County, Ohio has determined that an internet auction is a cost-effective method of disposing of such property; and,

WHEREAS, Section 505.10(D) of the Ohio Revised Code permits a board of township trustees to sell such property by internet auction after adopting a resolution expressing its intent to do so;

NOW, THEREFORE, BE IT RESOLVED by the Board of Trustees of Liberty Township, Trumbull County, Ohio, that:

Section 1: Pursuant to Ohio Revised Code Section 505.10(D), the Board of Trustees of Liberty Township hereby expresses its intent to sell personal property, including motor vehicles, road machinery, equipment, tools, or supplies, which is not needed for public use, or is obsolete, or is unfit for the use for which it was acquired by internet auction;

Section 2: The Board of Trustees of Liberty Township hereby authorizes the Township Administrator to execute a Memorandum of Understanding with GovDeals, Inc., 100 Capitol Commerce Boulevard, Suite 110, Montgomery, Alabama, 36117, to act as the representative of the Township to conduct the internet auctions on behalf of the Township;

Section 3: Such internet auctions shall be conducted according to the requirements of R.C. 505.10(D) under the following general terms and conditions:

All property will be offered for sale to the public on the www.govdeals.com website for a minimum of ten (10) days, including Saturdays, Sundays and legal holidays;

The Township reserves the right to establish a minimum price for any item and to establish other terms and conditions of sale, including but not limited to requirements for pick-up or delivery;

Township property auctioned via internet auction shall be sold to the highest qualified bidder at the conclusion of the auction;

The highest qualified bidder shall be required to pay in full for the property at the auctioned price plus the stated buyer's premium and all applicable taxes within five business days from the conclusion of the sale, and to comply with any other conditions or terms of sale;

All property is offered for sale "As-Is Where-Is" with Liberty Township making NO warranty, guarantee or representation of any kind, express or implied as to the condition of such property;

All vehicles will be sold with a Salvage Title; and

The Board of Township Trustees, Liberty Township, Trumbull County, Ohio reserves the right to reject any bids and to withdraw from sale any items listed on its internet auction.

Section 4: In the event that the Township reclaims the auctioned property as a result of the highest qualified bidder's failure to comply with the terms and conditions stated above or in the event that there are no bidders for the auctioned property who meet the terms and conditions established for the auction, the Township reserves the right, at its sole discretion, to re-auction the property or to dispose of the property without auction, as permitted by R.C. 505.10(B).

Section 5: That after adoption of this Resolution, the Fiscal Officer shall publish, in a newspaper of general circulation in the township, notice of Liberty Township's intent to sell unneeded, obsolete, or unfit-for-use township personal property by internet auction. The notice shall include

a summary of the information provided in this resolution. Information regarding the internet auction shall be published on the Township website and posted at the Township office.

Section 6: That this Resolution takes effect at the earliest time as maybe permitted by law;

Section 7: It has been determined that all formal actions of the Board of Trustees of Liberty Township concerning the adoption of this Resolution were adopted in an open meeting of the Board of Trustees of Liberty Township and that all deliberations of the Board of Trustees of Liberty Township which resulted in formal action were in meetings open to the public and in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code. Trustee Remarks:

Jodi Stoyak: February the board was all present for the Historical Society meeting on the 7th. A speaker was arranged for this meeting from our Liberty Township Veterans Affairs office on Belgrade. John Ely spoke

who is the director of this organization that formed 5 years ago. They provide many services for our local vets. They are looking to expand their offices on Frederick Street so they can have storage space for clothing and other items they provide for free to the veterans. They also accept used flags that they destroy properly.

On January 14th the Commissioners of Trumbull County signed a letter to the Mayor of Girard requesting a meeting with him and a council member to discuss the feasibility of purchasing the city's water infrastructure system that is currently in Liberty Township. The County also mentions in the letter that they don't want to move forward with the study without the city's support. This comment in the letter concerns me and confuses me as well. We have always known that the county ultimately owns the water lines. The City of Girard has been bringing in hundreds of thousands of dollars each year from the 1500 customers from Liberty Township. Liberty Township residents deserve a fair and equitable price for the water service they received from Girard. If the County purchases the system from Girard they would be able to provide the same water for almost half the cost to our residents.

I will be attending the County Emergency Management meeting tomorrow evening.

There will be a hearing this Thursday at 7pm at the Township Administration building regarding the sewer project along Tibbetts-Wick road and a section of Belmont Avenue. This project is being financed through an OPWC grant, a Community Development Block Grant, Appalachia Regional Commission grant and a 0% interest loan through the Ohio EPA for a total of \$3,419,112.00. I would like to thank Pat Ungaro for doing the leg work and discussions with the commissioners to move this project forward.

This Saturday the Fire Department will be memorializing Ed Conricote at Noon who died in the line of duty 15 years ago. A dedication will be held at the Logan Way station and light refreshments will be provided afterward.

In March, the township will once again be participating in Civic Day. We will host some of the Liberty High School students. Each year each department of the township provides them with information as to the services we provide to our residents. This has been a good program for our local students in educating them on local government.

Also, in March is Trumbull Mobile Meals program "March for Meals". It is a time for local officials to participate in the program by either helping to pack or deliver the meals to residents in Trumbull County. Lastly, The Liberty Township Firemen's Association is sponsoring its 56th annual Pancake breakfast on Sunday, March 31st at the W.S. Guy School from 8am until 2pm.
