Now therefore, based upon that decision, the charges issued May 27, 2020, the Investigative Summary Report #20-04/14 by the Liberty Police Department and the supporting documents and interviews from the investigation, the nature of the violations, and the employee's record, the Board of Trustees hereby demotes Cathy Macchione to the rank of firefighter in the Liberty Township Fire Department. She is not eligible for promotion for two years effective immediately.
